7. **New Business**

Adoption of revised SCDOT Safety Performance Numbers

Mr. Dennis Cyphers stated at the end of April 2021, SCDOT notified us that they would be sending out a revised copy their System Performance Report due to typos in a few of their tables. This report is based off SCDOT's Transportation Asset Management Plan (TAMP). Ms. Cyphers explained the Long-Range Transportation Plan (LRTP) uses these figures to create our safety measures and protocols for ranking criteria within the LRTP. Mr. Cyphers added these revised figures did not affect rankings for any of our projects. SCDOT contacted Mr. Cyphers and stated that our policy committees would need to approve the revised SCDOT Safety Performance Report.

Mr. Cyphers reviewed the two typos:

- Page 6, Table 3, SCDOT Pavement and Bridge Performance Measures, Section: Percentage of Pavements of the Non-interstate NHS in Poor Condition, Column Baseline the correct percentage is 8.6%.
- Page 10, Table 5 System Performance Congestion Mitigation & Air Quality Improvement Program, Section Total Emission Reductions: NOx, Column 4-Year Adjustment the correct number is 58.730.

Chairman Stewart called for a motion to approve the revised SCDOT System Performance Report. A motion was made by Mr. Jim McCain and seconded by Mr. Chuck Wilson. There being no discussion, Chairman Stewart called for the vote. All were in favor and the motion passed unanimously.
