## I. Call to Order, Welcome & Introduction

Chairman Calvin Hastie called the Santee-Lynches Workforce Development Board's (WBD) Youth Committee meeting to order at 10:21 AM and welcomed everyone.

## II. Approval of Minutes – January 19, 2018 and February 28, 2018 - (M)

Chairman Hastie called for a Motion to approve the Minutes from January 19, 2018 and February 28, 2018. A Motion was made by Ms. Veronica Robinson and seconded by Ms. Brenda Golden. There being no discussion, Chairman Hastie called for the vote. All were in favor and the Motion passed unanimously.

# III. Youth Performance Update

Ms. Tamara Wise, Program Manager, reviewed the Youth Performance Report for PYC for PY'17 through the period of May 10, 2018. Ms. Wise stated PYC has enrolled 163 participants as of May 10, 2018 (with a goal of 155.) They have had 23 high school students earn their diploma or GED.

Ms. Wise stated PYC recently held a two-day course called Career Smart. They now have a total of 87 participants that have been through the soft skills training.

Ms. Wise stated she has several community outreach events coming up:

The committee discussed having one place for the community to call, for all needs, if they have questions and would be directed to the appropriate agencies, churches, etc.

A discussion ensued regarding students attending a City Council meeting as a leadership development opportunity.

Ms. Sharon Teigue shared she attended a PYC staff meeting where Ms. Wise instructed staff to direct Ms. Teigue on how to make a peanut butter and jelly sandwich. The point of the exercise is learning how to follow directions and to include all directions because you may think you are telling people exactly what to do, but in reality, you're not.

## IV. Financial Report

Mr. Esmonde Levy provided the Youth Financial Report thru April 30, 2018 of Program Year 2017: Total Contract Amount - \$600,000; Actual Expenditures - \$496,978; Balance - \$103,022. PYC is on target for meeting the expenditure requirement of 85% of their total contract by the end of the program year.

Ms. Areatha Clark added, although the 85% has been met she encouraged them to continue to meet their goals. Ms. Clark specified the State requires 20% of funds be spent on Work-Based Learning type activities. She stated PYC is a little below the 20% and have been working diligently on getting more participants on a work experience or On-the-job training (OJT) assignment.

Ms. Sharon Teigue announced Sumter Adult Education will be having a Fast Tract GED class in June. Ms. Teigue then announced Sykes will be having a hiring event on May 30, and will be hiring for part-time positions. Ms. Teigue stated Sykes offers tuition reimbursement.

## V. Executive Session (Contractual Matter)

A Motion was made by Ms. Brenda Golden and seconded by Ms. Veronica Robinson to go into Executive Session to discuss a contractual matter.

A Motion was made by Ms. Veronica Robinson and seconded by Ms. Sharon Teigue to come out of Executive Session.

A Motion was made by Ms. Sharon Teigue and seconded by Ms. Veronica Robinson to extend Eckerd Workforce Development (dba Palmetto Youth Connections — PYC) contract for one additional year. All were in favor and the motion passed unanimously.

Ms. Clark added this motion will be carried forth to the Workforce Development Board on May 22, 2018 for full approval.

Mr. Hastie thanked committee members and staff for all they are doing for the youth in the community.
