INVITATION

The Santee-Lynches Regional Council of Governments (SLRCOG) is inviting bids to furnish and install an emergency diesel generator at the water system lift station at 1655 Seloc Road, Turbeville, SC 29162. SLRCOG reserves the right to reject any or all submittals not deemed responsive. Selection will be based upon the proposed cost of services outlined within this RFB, subject to the bidder providing proof of the minimum qualifications as defined.

Bids will be received until **12:00 P.M., local time, February 3, 2026**, after which time will be publicly opened and read. To qualify for consideration, **one (1) original** of your Bid plus one copy must be received by the office designated below by **the stated deadline**. It is the sole responsibility of the Bidder to see that the bid is received before the submission deadline. The Bidder shall bear all risks associated with delays in the U.S. mail or delivery service. Late Bids **will not** be considered. **Bids shall be accepted in person, by U.S. Mail or by private courier service.** **NO** proposal shall be accepted via oral or email communication, telephone, or fax transmission. Bids will be opened on February 4, 2026, in the presence of two (2) witnesses. Only the names of Bidders will be disclosed at that time.

A review panel will subsequently review and evaluate the bids according to the criteria outlined in Sections V-VII.

This solicitation does not commit Santee-Lynches to award a contract, to pay any cost incurred in the preparation of a proposal, or to procure or contract for the articles of goods or services. Santee-Lynches reserves the right to accept or reject any or all bids received as a result of this request, to negotiate with all qualified Vendors, or to cancel in part or in its entirety this proposal, if it is in the best interest of Santee-Lynches or the Authority to do so.

➤ QUESTIONS RECEIVED

1. “Can you provide the voltage requirements, phase, run time/tank size for diesel, as these are all critical to define the exact model?” **Please See attached picture for specifications.**
2. “Do you have setback requirements for the new generators and a location specified to put the units?” **This is a replacement generator; the location has been previously established.**
3. “Do you have engineer plans or requirements that engineer be provided by local municipality?” **There are no engineer plans or requirements, as this is the replacement of existing equipment.**
4. “Is a performance bond required for this project?” **Performance bond is not required.**
5. “What authority / jurisdiction will inspect this work (county or state)?” **Sumter County**
6. “The existing generator has an external fuel tank plumbed to the unit. Will the new generator include a sub-base fuel tank, or will it be tied into the existing external tank?” **The new generator will be tied into the existing external tank.**
7. “Is the existing automatic transfer switch (ATS) to remain and be reused?” **The existing automatic transfer switch (ATS) will remain and be reused.**
8. Please confirm the voltage of the new generator unit (277/480V). **Voltage: 277/480**
