09.02.2021	The City of Bishopville has returned the Request for Release of Funds and Certification form signed by Mr. McCutchen. This form is a part of the ERR for this project. The project amendment/extension has been submitted to SCDOC along with corrections to Survey Summary that was sent with the initial application. The Survey Summary had to be changed
	to reflect the properties that were added in the project amendment. Once the project amendment/extension has been approved, the next step will be to advertise for an Asbestos Survey company. During this time, the City of Bishopville is working with their attorney to have title searches completed and verified for demolition.
9.24.2021	ERR clearance arrived 9.23.2021; Updated bid packet documents; submitted admin request to advertise on SL website; directly solicited five companies; submitted advertisement for SCBO; sent email to City of Bishopville officials to schedule bid opening. Response received from Mr. McCutchen. Bid opening scheduled for 10.28.2021 at 2:00pm.
10.8.2021	Verified with Hannah Parler and that the City of Bishopville handbook was up to date. This was updated in the Section 504 Folder. An email was sent to Hannah regarding the signing of the Section 504 Compliance Schedules. The publication was sent to Lee County Observer to publish the Notice of Nondiscrimination. Will print on 10.20.21.
10/12/2021	Received the signed Section 504 Compliance Schedule and put into the Section 504 folder for Bishopville Harlem/Blue Pond Demo. Also, put hard copy in 504 Folder
10/28/2021	Santee Lynches held the bid opening in Bishopville for the asbestos. Summit is the apparent low bidder.
11/29/2021	SC Department of Commerce/Procurement have approved Asbestos Assessment Contract. The next step is to receive copies of the Title Searches and schedule a meeting with the City and the Contractor to have a contract signed.
12/07/2021	Zoom Meeting at 1:00pm with City Administrator, County Administrator, and Representative in reference to Administrative Funds for grant being exhausted due to project amendments (adding new properties-Environmental Review Reports)

12/29/2021	An email was sent to City of Administrator, requesting copies of the Title Searches to verify
	which properties are owned by heirs. The next step is to schedule a meeting with City
	Administrator and the Contractor for sign the contract and start the Asbestos testing on the
	properties that will be demolished.
1/5/2022	Per Government Services Department Chief, he will make a call to the City's attorney to
	advise him of next steps and actions needed, with this project.
	SLCOG/Grants Manager sent email to City Administrator and Summit Engineering to
1/14/2022	schedule a date and time for signing of contract. The City of Administrator has responded
	and a response from Summit is still pending.
1/26/2022	The Asbestos, Assessment, Project Design and Air Monitoring Professional Services Contract
	was signed today. The contract is between the City of Bishopville and Summit ELT. The
	expected start date is on or before February 9, 2022.
2/14/2022	From Summit ELT sent an email stating that they would be able to start the Asbestos
	inspections in Bishopville on Wednesday and Thursday of this week.
4/4/2022	SLRCOG/Grants Manager reached out to Summit to check the status of the inspection
	reports and received an email that some inspection reports would be received this week.
5/2/2022	SLRCOG/Grants Manager reached out to Summit in reference to the status of Asbestos
	Inspections reports that were supposed to be received by the week ending 4/8/2022.
5/3/2022	SLRCOG/Grants Manager left a voicemail for Contractor, however still no response received
	from Summit in reference to the status of Inspection reports.
5/4/2022	SLRCOG/Grants Manager left a voicemail for Summit, however still no response received
	from Summit in reference to the status of Inspection reports.

	out to Summit, again to find out the status of remaining inspection reports. SLRCOG/Grants
	Manager reached out via email to Summit for a status update on the Bishopville inspection
	reports. Summit responded back and advised that another individual would be working on
	the current back log for this project.
