208 CONFORMANCE REVIEW AND CERTIFICATION FEE SCHEDULE

The Board of Directors of the Santee-Lynches Regional Council of Governments has developed the following fee structure to address costs associated with the administrative costs of maintaining the Section 208 Federal Water Quality Planning Program. This program is administered locally by the Santee-Lynches Regional Council of Governments (3219 Broad Street, Sumter, SC 29150).

The Fee Schedule incorporates flat fees for each individual request for conformance. NO FEES are assessed for improvements to a public agency's systems.

The Phased Conformance request schedule is implemented as follows: Requestors that know their project will be constructed in multiple phases may submit a site plan for the entire project with a request for Phase 1 and be charged \$230. Each subsequent phase of the project will be charged a reduced fee of \$175. Projects which are submitted by phase with no overall review will be charged \$230 for each phase.
