1. Introduction

Santee-Lynches Area Agency on Aging is committed to increasing emergency readiness among seniors and care providers and NOAA best practices, priority is given to seniors and senior centers.

2. Scope of Work

Santee-Lynches Area Agency on Aging is seeking bids from qualified vendors to supply and deliver NOAA-certified weather alert radios for distribution to elderly residents and vulnerable members of the community. The goal is to improve emergency preparedness, especially for those who may not have access to smartphone alerts or internet-based warning systems.

Requirements:

- Estimated quantities (1,500 2,500 individual units, total cost to include shipping must not exceed \$30,000)
- Emergency Hand Crank Radio with LED Flashlight for emergencies, AM/FM NOAA Portable Weather Radio with minimum 2000mAh Power Bank Phone Charger, USB charged and Solar Power for Emergency (technical requirements, features, certifications)
- Shipping/delivery address: 3219 Broad Street, Sumter, SC 29150
- Provide user instructions (printed and/or visual guides), preferably in large print.
- Offer product warranty and technical support information
- Optional vendor services (training, setup support, instructional materials)

3. Bid Submission Requirements – (Mandatory to Submit <u>Template A – Bid Packet</u>) Bids must include a response to the following:

- 1. Company name, Tax ID number, contact information, and relevant experience.
- 2. Pricing breakdown (unit cost, shipping, bulk discount, if applicable). Unit Cost and shipping cannot exceed \$30,000
- 3. Product specifications must meet the minimum requirements below along with the warranty details
 - Emergency Hand Crank Radio with LED Flashlight for emergencies, AM/FM NOAA Portable Weather Radio with minimum 2000mAh Power Bank Phone Charger, USB charged and Solar Power for Emergency (technical requirements, features, certifications)
- 4. Estimated delivery timeline.
- 5. Submit Business License and Certificate of Liability

4. Additional Notes

- Radios must operate on NOAA weather band frequencies (162.400 162.550 MHz).
- Preferred for radios that allow zoning via SAME codes to target county level alerts.
- Vendors should consider models with user-friendly large buttons and audio prompts.
- State compliance with ADA and accessibility standards for elderly users.

Bids will be evaluated based on:

- Product quality and compliance with requirements
- Cost effectiveness
- Vendor reliability and delivery timeline

METHOD OF AWARD AND NOTIFICATION: BIDS WILL BE ANALYZED AND THE AWARD MADE, BASED ON THE EVALUATION CRITERIA FOR THIS BID, TO THE BEST QUALIFIED VENDOR. SANTEE-LYNCHES RESERVES THE RIGHT TO REJECT ANY OR

ALL BIDS AND ANY PART OF A BID; TO WAIVE INFORMALITIES, TECHNICAL DEFECTS, AND MINOR IRREGULARITIES IN BIDS RECEIVED.

CREDIT TERMS: VENDOR WILL INDICATE ALL DISCOUNTS FOR FULL AND/OR PROMPT PAYMENT.
